

COOKIE POLICY

The pages on the website (the “Website”) are published by Our Little Company Pte Ltd (“Our Little Company”), a company registered in Singapore with company registration number 201306833Z, whose registered address is at 150 Orchard Road, Orchard Plaza - #08-20, Singapore 238841, on behalf of Trilake Partners Pte Ltd, a company incorporated under the laws of Singapore with registration number 201104624H, whose registered address is at 39 Robinson Road #20-04 Robinson Point Singapore 068911 (“TLP”).

WHAT ARE COOKIES?

Our Little Company uses cookies to maintain your connection to TLP’s Website. A cookie is a small text file that is stored on your browser or the hard drive of your computer and mobile devices when you access certain websites. Cookies contain information that is transferred to your computer’s hard drive.

Cookies usually remember your personal or website settings, like your preferred language or address. When you visit the same website subsequently, your browser returns these text files belonging to that website. This enables the website to display information adjusted to your individual preferences.

On the first visit to the Website, you will be asked if you consent to the use of cookies. This consent can be withdrawn at any time.

WHICH COOKIES DO WE USE AND WHY?

Our Little Company uses the following cookies:

- **Strictly necessary cookies.** These are cookies that are strictly necessary for the normal functions of the Website. They include, for example, cookies that enable you to log in to secure areas of the Website, and do not store any personal data.
- **Analytical/performance cookies.** These allow Our Little Company to recognize and count the number of visitors and to see how visitors move around the Website when they are using it. This helps us to improve the way the Website works, for example, by ensuring that users are finding what they are looking for easily.
- **Functionality cookies.** These are used to recognize you when you return to the Website. This enables Our Little Company to personalize content for you by remembering your individual preferences.
- **Targeting cookies.** These cookies record your visit to the Website, the pages you have visited and the links you have followed. Our Little Company will use this information to make the Website and the advertising displayed on it more relevant to your interests. Our Little Company may also share this information with third parties for this purpose.

THIRD-PARTY COOKIES

Please note that third parties (including, for example, providers of external services such as web traffic analysis services) may also use cookies, over which Our Little Company and TLP have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

CHANGING YOUR COOKIE SETTINGS

Please note that internet browsers allow you to change your cookie settings. These settings are usually found in the 'options' or 'preferences' menu of your internet browser.

HOW TO WITHDRAW YOUR CONSENT
